As originally relayed in the 05/20/2021 Media Release the Auburn Police Dept. responded to a disturbance at the All-American Mart on 05/19/2021 @ 8:01 pm. The continued investigation into this matter revealed that a group of individuals had responded to the All-American Mart to confront the store owner, Zachary Pelosi-Dahl, in regards to an issue surrounding another individual. The confrontation, which was initially verbal, escalated into a physical altercation primarily between Pelosi-Dahl and Charles Williams. During the physical altercation inside the store pepper spray, tasers, knives, and batons were alleged to have been utilized by the involved parties. During the physical altercation to his head and Williams it was noted that Pelosi-Dahl sustained a laceration to his head and Williams sustained a stab wound.

Additionally Pelosi-Dahl exited the store after the others had left and he damaged a vehicle out in the parking lot.

Located in the All-American Mart for sale were metal knuckle knives along with more than 10,000 untaxed cigarettes.

Camille Racona, one of the individuals in the group that initially responded to the All-American Mart to confront Pelosi-Dahl, was also found to be in possession / operation of a stolen motor vehicle.

Arrest warrants were subsequently issued in regards to this matter charging Charles Williams, Camille Racona and Zachary Pelosi-Dahl with various crimes as noted on the attached pages.
