On August 7, 2022 at approximately 10:17 am the Auburn Police Department was called to 49 Grant Ave. for the report of a male that was deceased. Evidence was developed that the male had multiple stab wounds.

After notification of the next of kin, the deceased male has been positively identified as Michael Dennison of Auburn.

After further investigation the Auburn Police Department developed information linking one of Michael’s acquaintances, a Daniel Nachtsheim, as being at Michael’s residence in the early morning hours on 08/07/2022.

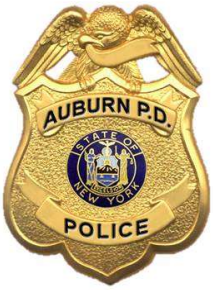
On 08/17/2022 Daniel was questioned by police and ultimately admitted to causing the death of Michael. A search of Daniel’s residence resulted in the recovery of evidence tying him to the crime.

After consultation with the Cayuga County District Attorney’s Office, Daniel Nachtsheim was charged with Murder 2nd. Daniel was subsequently held at the Cayuga County Jail, was arraigned at 0700 Hrs on 08/18/2022 at Centralized Arraignment Part Court, and was subsequently remanded to the Cayuga County Jail without bail
