On Tuesday, February 26, 2019 at 5:13 a.m. Auburn Police Officers responded to a Cottage St. residence for a reported domestic incident. Upon arrival, officers determined that a verbal argument had turned physical and that the male suspect had stomped on the female victim's bare feet with his work boots. The suspect continued to harass the victim by pushing her into a door and punching her in the head. The victim sustained minor injuries and refused medical treatment.

The suspect fled the scene prior to police arrival; he was identified as 31 year old Christopher Liddle. Other responding units located Liddle in a backyard of a Wall St. residence. A brief foot pursuit ensued when Liddle charged at two officers while holding a folding knife. The officers were able to tackle Liddle and place him into custody without further incident. None of the officers were injured during the encounter.
