On June 11th 2021 at approximately 9:02 am, members of the Auburn Police Department responded to 14 Garrow Street upstairs apartment to the report of a physical domestic dispute. Through an investigation conducted by members of the Auburn Police Department, it was determined that the suspect, Damien M. Smith, unlawfully entered the residence through the backdoor and assaulted the victim in the dining room and bathroom of the residence.

As a result of the investigation Damian M. Smith was arrested on the following charges:

- PL 140.30 burglary in the first degree, (B felony)
- PL 265.05 criminal possession of a weapon in the third degree (D felony)
- PL 120.05 assault in the second degree (D felony)
- PL 135.05 unlawful imprisonment in the second degree (A misdemeanor)
- PL 260.10 (2) counts of endangering the welfare of a child (A misdemeanor)
- PL 121.11 crim. obst. of breathing or blood circulation (A misdemeanor)
