On July 4th, 2021, at approximately 2:55 am, members of the Auburn Police Department responded to the area of Logan Street and Janet Street to the report of a suspicious incident in which a group of individuals were overheard talking about robbing someone. Upon arrival in the area by patrol officers, a disturbance was observed occurring in the 200 block of Janet Street. After a pursuit of multiple individuals running from the area an investigation was conducted and it was determined that an armed robbery had occurred. It was determined that a victim was assaulted and menaced with a firearm and a quantity of jewelry, money, and miscellaneous items were stolen from the victim's person and vehicle. During a search of the area by Auburn patrol officers, a loaded 9mm handgun was recovered.

As a result of the investigation the defendants were charged with the following.
