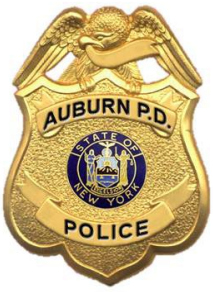

On July 28, 2022 at approximately 2:13 am Officer Gehm initiated a traffic stop on Fitch Ave for the failure to stop at the stop sign at Garrow St. As the officer attempted to conduct the traffic stop, the operator who was later identified as Kyreese T Gilliam, failed to comply and continued to drive away from officers. Gilliam continued eluding police until abruptly stopping the vehicle in front of his residence located at 14 Thornton Ave. Gilliam immediately got out of his vehicle and fled on foot behind the residence.

Officers Gehm and Spinelli pursued him on foot into the backyard. Gilliam was repeatedly reaching into the waistband area of his pants as he was running. The officers caught up to Gilliam and were able to take him into custody after a brief struggle as Gilliam continued to physically resist arrest.

Gilliam was found to be in possession of over one-half ounce of cocaine and more than \$4,000.00 in cash at the time of arrest. As a result of this arrest, Gilliam was also found to be in possession of a loaded 9mm.

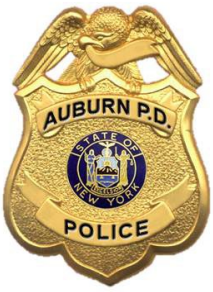
