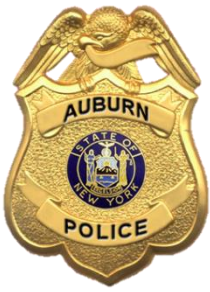

On July 28th, 2022 approximately 8:40 PM members of the Finger Lakes Drug Task Force (FLDTF) executed a search at the residence of 107 Owasco Street, following a drug investigation. During the execution of the search warrant members of the Auburn Police Department (APD) and FLDTF members located Kevin Soe on the side walk near the residence of 107 Owasco Street. FLDTF had information that Soe was dealing crack cocaine (cocaine base) out of the garage at 107 Owasco Street. Upon detaining and searching Soe he was found to be possession of 94 bags of crack cocaine with an aggregate weight of over a half of ounce and over \$1500.00 in US Currency. Soe was arrested, placed in custody and transported to the Auburn Police Department. FLDTF and APD also arrested Timothy Archambo, a resident of 107 Owasco Street, for his involvement during the investigation. Archambo knowingly maintained 107 Owasco Street as a place for people to gather and engage in the unlawful sale of controlled substances. Soe was processed and held for centralized arraignment. Acrahambo was released on an appearance ticket.
