On November 1, 2021 @ approximately 0538 hours members of the Auburn Police Department responded to the area of Grant Ave to assist the Cayuga County Sheriff's Office with a stolen vehicle complaint. Cayuga County 911 Dispatch advised that the vehicle was just stolen from 360 Grant Ave Road, Tractor Supply Co, and was headed towards the City. The vehicle was located, unattended, at KFC where it was found to have crashed into the building. Auburn Fire Department responded to KFC to control a gas leak.

Members of the New York State Police, Cayuga County Sheriff's Office and Auburn Police Department searched the area where they located suspect, later identified as Rashawn Wilborn, behind the Grant Motel.

The Cayuga County Sheriff's Office charged Wilborn with:

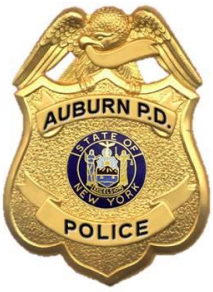
- Unauthorized use of Motor Vehicle in the 3<sup>rd</sup> Degree (PL - 165.05(1) (A Misdemeanor)

Wilborn was issued an appearance ticket and turned over to the custody of the Auburn Police Department where he was investigated for a burglary that occurred @ 0325 hours at the Grant Motel. Wilborn was found to have proceeds from the burglary on his person.

The Auburn Police Department charged Wilborn with:

- Burglary in the 2<sup>nd</sup> Degree (PL - 140.25(2) (C Felony)
- Petit Larceny (PL - 155.25) (A Misdemeanor)

Wilborn was also issued (6) Traffic Tickets in regards to the crash. Further criminal charges may be pending regarding the crash.
