On July 25th, 2022 around 7:21 PM the Finger Lakes Drug Task Force (FLDTF) observed Antoine Clark, who was a suspect from a shooting that occurred weeks earlier near Lavish Lounge, in the vicinity of Owasco Street. The FLDTF then observed Clark enter a white Toyota Camry as a rear passenger. The white Toyota then left the area of Owasco St. and started to travel northeast through the city while utilizing side streets. The FLDTF then coordinated with the Auburn Police Department (APD) Patrol Division to conduct a traffic stop on the white Toyota. APD Patrol Division then stopped the vehicle on N. Seward Avenue near Franklin Street. Upon interviewing the occupants the rear passenger was positively identified as Antoine Clark. Clark initially refused to exit the vehicle after being commanded multiple times to do so, but finally exited the vehicle. As Clark exited the vehicle he attempted to flee on foot, but was immediately stopped by APD. After a brief struggle in the middle of N. Seward Avenue Clark was placed into handcuffs and detained. While searching Clark he was found to be in possession of a loaded 9mm handgun, which was located in his waist band. Clark was also found to be in possession of 31.7 grams cocaine HCL, 10.7 grams cocaine base (crack cocaine), and 24.3 grams of a cutting agent, along with over \$2000.00 in US currency.

Clark was arrested and held pending centralized arraignment.
