On 05-26-19 at about 3:09 PM the Auburn Police Department was dispatched to 105 Genesee St. (Gusto Italiano) for a possible larceny.

Upon arrival Off. J. White and Off. V. Carnicelli discovered the business had been actually burglarized. During the investigation a description of the suspect was given to the patrol units and also during line up for the next shift, C-Line.

Shortly after shift change Off. P. Flickner located a male meeting the description near the corner of Jefferson St. and Orchard St. The individual was identified as James L. Sutton Sr. Sutton was then detained and transported to the Auburn Police Department to further the investigation. Det. M. Kalet was then called in to assist with the investigation.

Det. M. Kalet interviewed Sutton, who confessed to the incident. Sutton was then placed under arrest. Sutton was then processed and held pending arraignment.

James L. Sutton Sr. was charged with Burglary 3rd and Grand Larceny 4th.

This investigation is still ongoing.
