On March 6th, 2021 at approximately 12:19am Auburn Police Officers were dispatched to 117 S. Fulton St. on a reported burglary in progress. Auburn Police Officers were advised that a male suspect had stolen items from within the enclosed porch of the residence and was leaving on foot.

Upon their arrival Officers on scene observed a male subject in the area carrying a chair and a window blind. Once the subject spotted the Officers he dropped the items and began to run on foot. The suspect was quickly apprehended a short distance away without incident and subsequently identified as Randy E. Longley.

During a search of Longley incident to his arrest a dagger was located on Longley's person and was in his possession during the commission of the burglary thereby increasing the degree of the burglary offense. (The possessed weapon was not displayed or threatened during the incident, and no one was injured)

Longley is also under the supervision of the New York State Department of Corrections and Community Supervision – **Parole**, relative to a 2018 conviction for DWI-3rd Offense.

Longley was remanded to the Cayuga County Jail for pre-arraignment detention pending his arraignment this morning via a Centralized Arraignment proceeding.
