Members of the Auburn Police Department are looking for the public's assistance in identifying the suspect(s) involved in an overnight burglary that occurred on May 15th, 2022 at approximately 2:40AM at Verizon, 298 Grant Ave in the City of Auburn.

On May 15th, 2022 at approximately 2:40AM, a dark colored SUV pulled into Verizon's parking lot. One suspect exited the front passenger side of the vehicle and unlawfully entered the store while the second suspect waited in the vehicle.

The Auburn Police Department is seeking assistance from the public in identifying the individual or vehicle in the photographs. The vehicle in the photograph is possibly a 2017, 2018 or 2019 Ford Escape SE Sport. The color is unknown but appears to be dark gray or green. The suspect in the photograph appears to be a younger white male with a slim build.
