AUTHORIZING AN AGREEMENT WITH BIVENS & ASSOCIATES ARCHITECTS FOR PROFESSIONAL CONSULTING SERVICES

- WHEREAS, the Auburn City Council authorized Bond Ordinance #1 of 2020, which approved the expenditure of funds up to \$10 million allowing the City to proceed with the Auburn Public Safety Building Project; and
- WHEREAS, a request for proposals for related programming, design, construction documents, bidding and design-related construction administration services was released on January 17, 2020; and
- WHEREAS, the City received twelve (12) responses from various professional architectural firms resulting in two (2) proposal teams interviewed on February 13, 2020; and
- WHEREAS, Bivens & Associates Architects PLLC of Syracuse, NY is recommended as the highest ranked firm to provide the above mentioned professional consulting services for the Auburn Public Safety Building Project; and
- WHEREAS, it is now necessary that Bivens & Associates Architects PLLC of Syracuse, NY be awarded the contract for professional consulting services for the Auburn Public Safety Building Project in an amount not to exceed \$386,000.00.
- **NOW, THEREFORE, BE IT RESOLVED** that the Auburn City Council does hereby award a contract to Bivens & Associates Architects PLLC of Syracuse, NY for all programming, design, construction documents, bidding and construction administration phases of the Auburn Public Safety Building Project in an amount not to exceed \$386,000.00; and
- **BE IT FURTHER RESOLVED** that the Mayor, or appointed designee, is authorized to sign the agreement and all other documents relating to the agreement on behalf of the City of Auburn; and
- **BE IT FURTHER RESOLVED** that the cost of the professional consulting services agreement in the amount of \$386,000.00 is to be charged to the Public Safety Building capital account #HA1620-440-PSB.
