## AUTHORIZING AN AGREEMENT WITH HUEBER-BREUER FOR CONSTRUCTION MANAGEMENT SERVICES

WHEREAS, the Auburn City Council authorized Bond Ordinance #1 of 2020, which approved the expenditure of funds up to \$10 million allowing the City to proceed with the management, design, construction, and inspection phases of the Auburn Public Safety Building Project; and

WHEREAS, a request for proposals for construction management services was released on November 12, 2019 with the City receiving six (6) responses from construction and engineering firms, and four (4) consulting teams were interviewed on December 20, 2019; and

WHEREAS, Hueber-Breuer Construction Co., Inc., Division of Fire Protection Services was selected as the top qualified consulting team to provide construction management services for the Auburn Public Safety Building Project; and

**WHEREAS,** it is now necessary that Hueber-Breuer Construction Co., Inc. be awarded the contract for the construction management services portion of the Auburn Public Safety Building Project in an amount not to exceed \$831,750.00.

**NOW, THEREFORE, BE IT RESOLVED** that the Auburn City Council does hereby award a contract to Hueber-Breuer Construction Co., Inc., for the construction management services portion of the Auburn Public Safety Building Project in an amount not to exceed \$831,750.00; and

**BE IT FURTHER RESOLVED** that the Mayor, or appointed designee, is authorized to sign the agreement and all other documents relating to the agreement on behalf of the City of Auburn; and

**BE IT FURTHER RESOLVED** that the cost of the construction administration and inspection services in the amount of \$831,750.00 is to be charged to the Public Safety Building capital account #HA1620-440-PSB.
