To avoid a \$50.00 late fee the renewal is due and must be *received in* the Code Enforcement Office on or before December 31, 2023. Failure to renew by January 31, 2024 will result in revocation of your license.

Also attached please find a Certification of Corporate Ownership form and Certification of Employees form that must be completed and returned to the Code Enforcement Office along with your License Renewal.

There will be additional License Renewal forms, Certification of Corporate Ownership forms and Certification of Employee forms in the Code Enforcement Office and at www.auburnny.gov on the Code Enforcement web-page for your convenience.

If you choose to mail in your application please make checks payable to "City of Auburn". Please make sure the forms are filled out completely and correct insurance documents are enclosed. Any missing information will hold up the processing of your license.

2024 PLUMBING LICENSE RENEWAL

This is a notice to remind you that renewal of your Plumbing License for 2024 is due on or before **December 31, 2023**, after which there will be a \$50.00 late fee in addition to the renewal fee. **If your license is not renewed by January 31, 2024 it will be revoked. This will be your only notice.** In order to renew your license, you must provide proof of coverage for the following insurances on the specified forms. **If you have employees or subcontractors you must have Worker's Compensation and Disability insurances, violation of this requirement will result in immediate license revocation without exception.**

- Worker's Compensation: U-26.3 (State Insurance Fund), C-105.2 (Private Carrier), SI-12 (Self-Insured) or GSI-105.2 (Group Self-Insured)
- **Disability**: DB-120.1 or DB-155 (Self Insured)
- **Self-employed or a Partnership**, with *NO EMPLOYEES OR SUBCONTRACTORS*, Requires a CE-200 on-line application available at www.businessexpress.ny.gov (Instructions for the CE-200 may be found on the Code Enforcement page of the City web-site).
- Liability insurance is acceptable on the ACORD form with minimum coverage as follows:

Master Plumber \$1,000,000/\$2,000,000 Drain Layer \$150,000/\$300,000

The City of Auburn must be listed as a Certificate Holder on all of the above policies.

We are requesting that you bring this completed application and your employee records, i.e. start and finish dates for Apprentice, Journeyman and Master, when applying. This may be a little inconvenient, but it will improve our record keeping and make this information available for proof of time on the job toward advancement. You can renew your license in person, at the Code Enforcement Office located in the basement of City Hall, 24 South St, Auburn, NY on Mondays through Fridays from 8am-4pm.
