The City of Auburn has announced a public comment period will be held from June 12, 2020 through June 30, 2020 to receive public input on the future Public Safety Building that will be built at city-owned property located at 31 Seminary Street.

PROJECT SITE: The project site is located at 31 Seminary Street which sits at the intersection of Seminary Street and Nelson Street in the City of Auburn. The property neighbors the Willard Memorial Chapel on 17 Nelson Street on the north boundary, and the former Sav-a-lot plaza on Seminary Street to the west boundary.

PROJECT DESIGN TEAM: The City of Auburn Public Safety Building project team includes city staff with representatives from the engineering, city manager, fire and planning departments, as well as, the Mayor's Office. In January of 2020 the City of Auburn has hired Hueber-Breuer Construction Company, Inc. of Syracuse NY to be the construction administration and management firm for this project and in February of 2020 the City hired Bivens + Associates Architects of Syracuse, NY to be the design firm on record for the project.
